Items for discussion:

1. Updates to Chapter 38 Fire Department Personnel Ordinance

Chief Winters explained that a member of the public safety committee should not be involved in the promotion process. This is an area where the council and departments need the separation of duties. Chief Winters also explained that currently, the ordinance states that the lieutenants can be on call all weekend and take a command vehicle home. Chief Winters would like that section removed. The lieutenants are not salary so we would have to pay them the entire time they have the command vehicle at home with them. Alderman Greer made a motion to this item be placed on the 15<sup>th</sup> August 2023 COW agenda for discussion. Alderwoman Winters 2<sup>nd</sup>. All in favor

2. Updates to Chapter 90 Neighborhood Vehicle Ordinance

Clerk Malmstrom has put together information from other municipalities. In the new Ordinance, we would require Golf Carts to be inspected. A registration sticker would be required to be purchased and placed on the golf cart. Alderman Greer would like to have this item tabled so we can do further research. Alderman Greer made a motion to table this item for now and come back to the committee after more research is done. Alderwoman Winters 2<sup>nd</sup>. All in favor

3. Application for Outdoor Special Event

Rock River Coin and Jewelry is requesting a Special Event Permit for a grand opening event with a band Saturday, August 19<sup>th</sup> from 1-4 pm. The only request that the council has on this is that the band face away from 1<sup>st</sup> Ave. Alderman Greer made a motion to this item be placed on the 15<sup>th</sup> August 2023 Regular Council agenda for discussion and possible action. Alderwoman Winters 2<sup>nd</sup>. All in favor
